I'm very excited to say that I received my Canadian PR visa yesterday. I would like to use this opportunity to thank Mr. Colin Singer and his staff for the great job they did in handling my case.

I started thinking seriously about moving to Canada in November of 1996 and since I wanted the process to go as quickly and smoothly as possible I decided to hire a professional to help with my case. I spent about 2 weeks researching various Canadian law firms and consulting firms. I'm generally very perfectionist in everything I do and I pay a lot of attention to details. Picking the right firm was not a small issue for me so I spent a lot of time on it. I picked 5 law firms and consulting services and did a thorough research on each one. I narrowed down my choices to 2 law firms based on

their experience, credentials, good references, and their availability and willingness to answer my questions. After talking to Mr. Singer over the phone I was convinced that his firm provided the services that I was looking for.

Once I signed a contract with Mr. Singer. It took me about 2 months to prepare all the documents that I needed for my application (FBI report, new passport, etc.). I filed with the Buffalo APC on Feb 10, 1997.

For those of you who are interested, here is the timetable for the process I went through:

Nov 15, 1997 Signed a contract with Mr. Singer.

Dec 6, 1996 Sent for my FBI criminal record check.

Jan 27, 1997 Received reply from FBI.

Feb 10, 1997 Sent application to IAPC in Buffalo.

Apr 22, 1997 Received medical form and interview waiver.

May 05, 1997 Completed medical examination.

July 15, 1997 Received news from Mr. Singer that my PR visa has arrived. I must say that Mr. Singer and his staff did an excellent job preparing my case. They made the entire process almost painless for me. Since last November I've been in regular contact with Mr. Singer through telephone, fax, and email. Most of the time I used email and almost always I received a reply on the same day or at most within a working day. The responses were always to the point and very professional. I received my visa about a month earlier than my most optimistic predictions.

I strongly recommend Colin Singer to anyone who is planning to hire an immigration lawyer or consultant.

Here follows a detailed description of my process:

My process :

August 6 - free assessment filled in www.singer.ca

August 7 - received positive answer from Dr. Colin Singer- I would qualify for immigration to Canada

August 7 - All my doubts about application were sent to his office(lots of questions) ; no engagement in his services but all my questions were answered on the same day by Dr.Singer

August 22 - Finally I decided , (I had been searching since January about legal counselling, who to contact etc...) to engage legal counselling - Dr. Colin Singer. I contacted him by e-mail and he sent me a fax with contract

August 23 - Dr.Singer sent me all instructions needed for him to prepare my application. (documents, translations, documents to be prepared by law court etc...)

October 7 - I had all documents ready and sent to Dr.Singer (my delay was due to the volume of translations needed)

October 15 - Mail from Dr.Singer asking for clarifications and informing that they would have the submission ready in a week.

October 22- In the exact time I received all documents to be submitted to the Consulate, wonderfully prepared with a very professional and well prepared cover letter from Dr.Singer to the Consulate (Sao Paulo-Brazil).

October 29 - Documents sent to the consulate with fees payed etc...

November 4 - DHL delivered documents in Consulate

December 20 - Dr.Singer informs me that a communication from consulate was received and additional documents needed (proof of children custody, etc..) . He also informed that medical forms were being sent to me and that I was interview waived . He also sent me all instructions for my CCPE assessment to be processed and his office made the payment necessary etc... so, it was a absolutly painless process. They took care of everything.

February 4 - Medical exams started - (It was my option to wait a while before having medicals)

February 20 - Medical exams concluded and sent to Consulate by doctor

February 28 - Additional documents asked by Consulate were sent to Dr. Singer who sent them to the Consulate as soon as they arrived in his hands (on March 3rd)

June 3 - Finally another letter from consulate but asking another custody document

June 26 - Documet sent to Dr.Singer who mailed it to Consulate(last document they asked for was a judge declaration of custody)
